The board discussed adding a social media coordinator with the biggest issue being how to integrate a volunteer social media coordinator into board activity and coordinate with Kelsee. We will continue to follow this subject as it seems to be of interest to many members.

Sue discussed that we could invite people who want to communicate with the board to email the KGBA email and all board members. Ashley felt that we need to maintain communication through the KGBA email so that a single board member is not placed on the spot, and it establishes a paper trail. John suggested using a "bcc" link for emails but then Ashley described the number of emails she gets that are routine registration questions, so John withdrew the suggestion. Ashley suggested

we continue the current method of handling emails and sending a compilation of the emails since the last meeting a week before the board meeting for everyone to review.

John suggested that we do a little self-promotion on the accomplishments of the KGBA over the last several years. Stephanie suggested that we have a regular column in the newsletter called "What has the board done for you". Everyone was in agreement that we need to get the word out about the good things happening with the KGBA.
